## APPOINT DEAN, COLLEGE OF LAW, URBANA

**Action:** Approve Appointment of Dean, College of Law, Urbana

**Funding:** State Appropriated Funds

The Chancellor at Urbana has recommended the appointment of Bruce Smith, presently Professor and Associate Dean for Academic Affairs, College of Law, University of Illinois at Urbana-Champaign, as Dean of the College of Law, non-tenured, on a twelve-month service basis, on 100 percent time, at an annual salary of \$255,000 (equivalent to an annual nine-month base salary of \$208,636 plus two-ninths annualization of \$46,364), and an administrative increment of \$30,000, for a total salary of \$285,000, beginning February 16, 2009.

Dr. Smith will continue to hold the rank of Professor, College of Law, on indefinite tenure, on an academic year service basis, on zero percent time, non-salaried, effective February 16. 2009. He is succeeding Ralph Edwin Brubaker, who succeeded Charles J. Tabb, as Interim Dean following former Dean Heidi M. Hurd's decision to return to full-time faculty service in the College effective August 16, 2007.

The Board action recommended in this item complies in all material respects with applicable State and Federal laws, University of Illinois *Statutes, The* 

General Rules Concerning University Organization and Procedure, and Board of Trustees policies and directives.

This recommendation is based upon the support of a search committee<sup>1</sup>, faculty and administrative leaders of the college, and the Provost and Vice Chancellor for Academic Affairs.

The Vice President for Academic Affairs concurs with this recommendation.
