APPOINT DIRECTOR, DEPARTMENT OF INTERCOLLEGIATE ATHLETICS,  
SPRINGFIELD

**Action:** Appoint Director, Department of Intercollegiate Athletics

**Funding:** State Appropriated Funds

The Chancellor, University of Illinois at Springfield, and Vice President, University of Illinois recommends the appointment of Peyton Deterding as Director, Department of Intercollegiate Athletics, Springfield. This will be a non-tenured appointment, on a twelve-month service basis, on 100 percent time, at annual salary of \$120,000 effective January 17, 2020. Mr. Deterding was appointed as Director-Designate of Intercollegiate Athletics under the same terms beginning December 9, 2019.

Prior to accepting this appointment as Director of the Department of Intercollegiate Athletics, he has served since 2016 as the Senior Associate Athletic Director-Internal Operations at Illinois State University. At Illinois State University, he has also served as Associate Athletic Director-Internal Operations and Assistant Athletic Director-Facilities and Operations.

Mr. Deterding succeeds Dr. Clarice Ford, who has served on an interim basis since July 1, 2019.

The Board action recommended in this item complies in all material respects with applicable State and federal laws, University of Illinois *Statutes, The General Rules Concerning University Organization and Procedure*, and the Board of Trustees policies and directives.

This recommendation is made with the advice of a search committee.<sup>1</sup>

The President of the University concurs with this recommendation.
