APPOINT INTERIM VICE CHANCELLOR FOR RESEARCH, CHICAGO

Action: Approve Appointment of Interim Vice Chancellor for Research, ChicagoFunding: State Appropriated Funds

The Interim Chancellor at Chicago has recommended the appointment of Larry H. Danziger, currently Professor of Pharmacy Practice, Pharmacotherapist, and Co-Director of Infectious Diseases, College of Pharmacy; Associate Vice Chancellor for Research and Compliance Officer, Office of the Vice Chancellor for Research; and Assistant Professor of Pharmacy, Department of Medicine, College of Medicine at Chicago as Interim Vice Chancellor for Research, non-tenured, on a twelve-month service basis, on 100 percent time, at an annual salary of \$180,000, with an administrative increment of \$20,000, beginning January 1, 2008. In addition, Dr. Danziger will continue to hold the position of Co-Director of Infectious Diseases, College of Pharmacy, Chicago, non-tenured, on a twelve-month service basis, with an administrative increment of \$5,000, effective January 1, 2008; Pharmacotherapist, College of Pharmacy, Chicago, non-tenured, on a twelve-month service basis, on zero percent time, non-salaried, effective January 1, 2008; and Assistant Professor of Pharmacy, College of Medicine at Chicago, non-tenured, on a twelve-month service

basis, on zero percent time, non-salaried, effective January 1, 2008, for a total salary of \$205,000.

Dr. Danziger will continue to hold the rank of Professor of Pharmacy Practice on indefinite tenure, on a twelve-month service basis, on zero percent time, nonsalaried.

Dr. Danziger will succeed Eric A. Gislason who, effective January 1, 2008, will become Interim Chancellor at the Chicago campus until a permanent Chancellor is appointed.
