INTERIM VICE PRESIDENT FOR TECHNOLOGY AND ECONOMIC  
DEVELOPMENT

**Action:** Approve Appointment of Interim Vice President for Technology and Economic Development

**Funding:** State Appropriated Funds

I recommend the appointment of James A. Weyhenmeyer, presently Associate Vice President for Technology and Economic Development, as Interim Vice President for Technology and Economic Development, non-tenured, on a twelve-month service basis, on 100 percent time, at an annual salary of \$187,500 and an administrative increment of ~~\$15,000~~ \$25,000, for a total salary of ~~\$202,500~~ \$212,500, beginning January 22, 2007.

Dr. Weyhenmeyer will hold this position until a search has been conducted and a permanent vice president assumes the duties of the position. He will continue to hold the rank of Professor of Pathology, University of Illinois College of Medicine at Urbana-Champaign, on indefinite tenure on an academic year service basis on zero percent time; Professor of Medical Cell and Structural Biology, University of Illinois College of Medicine at Urbana-Champaign, on indefinite tenure on an academic year service basis on zero percent time; and Professor of Cell and Developmental Biology and

Neuroscience, College of Liberal Arts and Sciences, University of Illinois at Urbana-Champaign.

He succeeds David L. Chicoine who resigned December 31, 2006, to become President of South Dakota State University, Brookings.

The board action recommended in this item complies in all material respects with applicable State and federal laws, University of Illinois *Statutes, The General Rules Concerning University Organization and Procedure*, and Board of Trustees policies and directives.

This appointment has been reviewed by the University Senates Conference.
