PURCHASE RECOMMENDATION

The "Purchase Recommendation" is presented by campus and a Summary from "Appropriated Funds" (i.e., from State appropriations to the University) and from "Institutional Funds" is included. The latter term is used here to designate funds received by the University under contracts with the United States Government; contracts with private corporations and other organizations, from foundation grants, and grants from corporations and other donors; and University revolving funds authorized by law. The Summary also indicates a total amount by campus.

The Board action recommended in this item complies in all material respects with applicable State and federal laws, University of Illinois Statutes, The General Rules Concerning University Organization and Procedure, and Board of Trustees policies and directives.

The Director of Purchases has proposed and the Vice President, Chief Financial Officer and Comptroller recommends the following purchase. Unless otherwise specified, the purchase in each case is recommended on the basis of the lowest acceptable bid.

Item Consulting services to assist in the transformation of the University of Illinois Hospital and Health Sciences System (UIHHSS) clinical enterprise for the period March 18, 2013 through June 30, 2016, with the option to renew for two additional one-year periods. All renewals are subject to continuing need, availability of funds, satisfactory performance, and Board of Trustees' approval.

Competitive selection procedures were followed in accordance with the Illinois Procurement Code.

The vendor will provide strategic, operational, consultative, and change management services designed to transform the clinical enterprise organization through efforts focused on immediate and long-term strategic and operational planning, business process optimization, total quality improvement, and talent management. The change process is expected to lead to improvements in the University of Illinois Hospital and Health Sciences System (UIHHSS) structures and processes that drive clinical, operational, and financial business results, while cultivating an engaged, results-driven culture to sustain the change.

The recommended vendor was selected in accordance with State Procurement rules. After technical review of the submitted proposals, evaluations relative to project criteria, and discussions with the two highest-ranked vendors, it was determined that Navigant Healthcare was both the most qualified and lowest cost vendor.

The recommended vendor has agreed to subcontract with a female-owned, MAFBE-certified firm.
