APPOINT DEAN, COLLEGE OF BUSINESS ADMINISTRATION, CHICAGO

Action: Appoint Dean, College of Business Administration

Funding: State Appropriated Funds

The Vice President, University of Illinois, and Chancellor, University of Illinois at Chicago recommends the appointment of Michael B. Mikhail, presently KPMG Professor and Director, School of Accountancy, W.P. Carey School of Business, Arizona State University Main, Tempe, as Dean, College of Business Administration, non-tenured, on a twelve-month service basis, on 100 percent time, at an annual salary of \$301,889 (equivalent to an annual nine-month base salary of \$247,000 plus two-ninths annualization of \$54,889), plus an administrative increment of \$48,111, beginning August 16, 2012, for a total annual salary of \$350,000.

In addition, Dr. Mikhail will be appointed to the rank of Professor of Accounting, College of Business Administration, on indefinite tenure, on an academic year service basis, on zero percent time, non-salaried, beginning August 16, 2012.

Dr. Mikhail succeeds Stefanie Lenway, who last served the role on a permanent basis. Michael Anthony Pagano, Dean of the College of Urban Planning and Public Affairs, has been serving in the position on an interim basis while a national search was conducted.

The Board action recommended in this item complies in all material respects with applicable State and federal laws, University of Illinois *Statutes, the General Rules Concerning University Organization and Procedure*, and the Board of Trustees policies and directives.

This recommendation is made with the advice of a search committee.¹

The Vice President for Academic Affairs concurs.

The President of the University recommends approval.
