APPOINT ACTING DEAN, COLLEGE OF PUBLIC AFFAIRS AND
ADMINISTRATION, SPRINGFIELD

Action: Appoint Acting Dean, College of Public Affairs and Administration

Funding: State Appropriated Funding

The Chancellor, University of Illinois at Springfield, and Vice President, University of Illinois has recommended the appointment of David P. Racine as Acting Dean, College of Public Affairs and Administration, non-tenured, on a twelve-month service basis, with a monthly administrative increment of \$2,000, beginning July 27, 2015. Dr. Racine will continue to serve as the Executive Director, Center for State Policy and Leadership, non-tenured, on a twelve-month service basis, on 100 percent time, at an annual salary of \$143,500; and Director, Institute for Legal, Legislative and Policy Studies, non-tenured, on a twelve-month service basis, on zero percent time, non-salaried.

In addition, he will continue to serve as Executive Director/Interim Emiquon Director, non-tenured, on a twelve-month service basis, with a monthly administrative increment of \$1,200, for a total annual salary of \$181,900. Dr. Racine was appointed to serve as Acting Dean Designate under the same conditions and salary arrangement beginning June 19, 2015.

The Board action recommended in this item complies in all material respects with applicable State and federal laws, University of Illinois *Statutes*, *The General Rules Concerning University Organization and Procedure*, and Board of Trustees policies and directives.

This recommendation is made with the advice of the Provost and Vice Chancellor for Academic Affairs.

The Vice President for Academic Affairs concurs.

The President of the University recommends approval.
