APPOINT INTERIM DEAN, COLLEGE OF NURSING, CHICAGO

Action: Appoint Interim Dean, College of Nursing, Chicago

Funding: State Appropriated Funds

The Chancellor at Chicago has recommended the appointment of Mi Ja Kim, currently Professor of Biobehavioral Health Science, and Director of the Academy of International Leadership Development, College of Nursing, University of Illinois at Chicago, as Interim Dean of the College of Nursing, non-tenured, on a twelve-month service basis, on 100 percent time, at an annual salary of \$175,000, with an annual administrative increment of \$10,000, for a total salary of \$185,000, beginning July 16, 2009.

Dr. Kim will continue to hold the rank of Professor of Biobehavioral Health Science, College of Nursing, on indefinite tenure, on a twelve-month service basis, on zero percent time, non-salaried, effective July 16, 2009; and Director of the Academy of International Leadership Development, College of Nursing, non-tenured, on a twelve-month service basis, on zero percent time, non-salaried, effective July 16, 2009.

Dr. Kim will replace Joan L. Shaver, who is resigning to accept a position as Dean of Nursing at the University of Arizona, Tucson on July 15, 2009.

The Board action recommended in this item complies in all material aspects with applicable State and federal laws, University of Illinois *Statutes, the General Rules Concerning University Organization and Procedure*, and the Board of Trustees policies and directives.

This recommendation is made with the advice of the faculty and the Executive Committee of the College.

The Vice President for Academic Affairs concurs with this recommendation.
