



Higher Education General Fund Appropriations By Sector






GRF Appropriations for FY 2002 – FY 2012

State Appropriation Revenue


Unrestricted Funds Billings and Collections through June 6, 2011





Unrestricted Funds Fiscal Year 2007-2011











Federal Grants & Contracts Expenditures All Functions – Total University



Overall utility budget and individual campus budgets will have a positive outcomes in Fiscal Year 11.

The deficit will be reduced by approximately \$9 million in Fiscal Year 2011 to approximately \$91 million overall.

The campus deficits at year end will be approximately \$71 million UIUC, \$19 million UIC and \$1 million at UIS.

Each campus has developed and is executing a utility deficit reduction plan.
