First semester 2017-18, full pay

To research fundamentals of soft robotics, a subfield of robotics dealing with non-rigid robots constructed with soft and deformable materials; and to launch new research projects that integrate our unique material systems with a robotic design.

First semester 2017-18, full pay; <u>or</u> second semester 2017-18, full pay To develop expertise in tissue engineering and vascular biology, especially characterization of how cells interact with surfaces on each other, which will impact and enhance current approaches; and to publish articles on this topic and transfer this expertise into a course.

First semester 2017-18, full pay
