AWARD CONTRACTS FOR ROGER ADAMS LABORATORY FACILITY PLAN, PHASE I, URBANA

Action: Approve Award of Contracts for Roger Adams Laboratory Facility Plan,

Phase I, Urbana

Funding: Grant Funds and Institutional Funds Operating Budget

In November 2005, the Board approved Phase **<u>4I</u>** of the Roger Adams

Laboratory Facility Plan project for \$7.6 million with a \$124 construction cost per gross square foot. This project provides for rehabilitation and laboratory renovation of approximately 31,901 square feet. Phase I involves the renovation of the third and fourth floors, replacement of designated windows, and upgrades to infrastructure.

The Chancellor at Urbana with the concurrence of the appropriate administrative officers recommends that the following contracts¹ for the Roger Adams Laboratory Facility Plan, Phase I project be awarded. Competitive bidding procedures in accordance with the Illinois Procurement Code were followed; and the awards are to the
