## APPOINT DEAN, COLLEGE OF LIBERAL ARTS AND SCIENCES, SPRINGFIELD

Action: Approve Appointment of Dean, College of Liberal Arts and Sciences, Springfield

Funding: State Appropriated Funds

The Chancellor at Springfield has recommended the appointment of James W. Ermatinger, presently Dean, College of Liberal Arts, Bloomsburg University of Pennsylvania, as Dean, College of Liberal Arts and Sciences, non-tenured, on a twelvemonth service basis, on 100 percent time, at an annual salary of \$100,000 and an administrative increment of \$45,000, for a total salary of \$145,000, beginning July 1, 2009.

Dr. Ermatinger will hold the rank of Professor of History, on indefinite tenure, on an academic year service basis, on zero percent time, non-salaried, beginning July 1, 2009. He will succeed Margot I. Duley, who served as Professor, History Program and Women and Gender Studies Program and Dean, College of Liberal Arts and Sciences, from August 2004 and is retiring effective June 30, 2009. The Board action recommended in this item complies in all material respects with applicable State and federal laws, University of Illinois *Statutes*, *The General Rules Concerning University Organization and Procedure*, and Board of Trustees policies and directives.

This recommendation is made with the advice of a search committee.<sup>1</sup>

The Vice President for Academic Affairs concurs.

The President of the University recommends approval.
