**Action:** Approve Appointment of Vice Chancellor for Student and Administrative Services and Dean of Students, Springfield

**Funding:** State Appropriated Funds

The Chancellor at Springfield has recommended the appointment of L. Christopher Miller, currently Vice Chancellor for Student Affairs and Dean of Students, University of Illinois at Springfield, as Vice Chancellor for Student and Administrative Services and Dean of Students at Springfield, non-tenured, on a twelve-month service basis, on 100 percent time, at an annual salary of \$113,020, beginning January 1, 2006.

Dr. Miller will assume this new position due to the administrative reorganization of student affairs and administrative affairs, and elimination of the position of Vice Chancellor for Administration.

The board action recommended in this item complies in all material respects with applicable State and federal laws, University of Illinois *Statutes*, *The General Rules Concerning University Organization and Procedure*, and Board of Trustees policies and directives.
