## APPOINT INTERIM VICE CHANCELLOR FOR STUDENT AFFAIRS, SPRINGFIELD

**Action:** Appoint Interim Vice Chancellor for Student Affairs

**Funding:** State Appropriated Funds

The Chancellor, University of Illinois at Springfield, and Vice President, University of Illinois recommends the appointment of Clarice Renee Ford, presently Associate Vice Chancellor for Student Services, as Interim Vice Chancellor for Student Affairs, non-tenured, on a twelve-month service basis, on 100 percent time, at an annual salary of \$140,000, beginning November 14, 2014. Dr. Ford was appointed to serve as Interim Vice Chancellor for Student Affairs-Designate, under the same conditions and salary arrangement, effective October 13, 2014.

Dr. Ford will continue to hold the position of Associate Vice Chancellor for Student Services, on a twelve-month service basis, on zero percent time, non-salaried, effective October 13, 2014.

Dr. Ford succeeds Timothy L. Barnett who resigned August 5, 2014.
