# APPROVE APPOINTMENTS TO THE BOARD OF DIRECTORS OF WOLCOTT, WOOD AND TAYLOR, INC., CHICAGO

Action: Confirm Appointments to the Board of Directors of Wolcott, Wood and Taylor, Inc., Pursuant to the WWT Bylaws.

**Funding:** No New Funding Required

Pursuant to Article II, Section 2.2(b) and Article III, Section 3.2 of the Bylaws of Wolcott, Wood and Taylor, Inc. ("WWT"), The Board of Trustees of the University of Illinois, as the sole member of WWT, has the authority to approve the appointments to the WWT Board of Directors (the "WWT Board") of up to five individuals selected by the Vice President for Health Affairs ("VPHA"), at least one of whom shall be a person with financial expertise, elected annually by the sole member. The individuals selected by the VPHA and elected by the sole member will serve on the WWT Board along with four other individuals, for a total of up to nine WWT Board members, as set forth in the WWT Bylaws.

The VPHA recommends the following four candidates to be elected by the sole member to the WWT Board each for a one year term, effective immediately: Bryan Becker, M.D., William L. Devoney (financial expertise), Avijit Ghosh, Ph.D., and Jaewon Ryu, M.D., J.D.

Brief biographical information of these four individuals is attached.
