## APPOINT INTERIM DIRECTOR, DISCOVERY PARTNERS INSTITUTE

**Action:** Appoint Interim Director, Discovery Partners Institute

**Funding:** State Appropriated Funds

I recommend the appointment of William H. Sanders, presently Professor and Head, Department of Electrical and Computer Engineering, in the College of Engineering, University of Illinois at Urbana-Champaign, to serve as Interim Director of the Discovery Partners Institute, non-tenured, on a twelve-month service basis, on 100 percent time, at an annual salary of \$387,000, beginning October 1, 2018. He has served as Interim Director of the Discovery Partners Institute Designate under the same terms and conditions since August 16, 2018.

The Interim Director of the Discovery Partners Institute will lead the Discovery Partners Institute, overseeing all aspects of the institute including the development of corporate partnerships; faculty and staff hiring; budget; student academic and curricular experiences; fundraising and philanthropy; facility planning, acquisition, and construction; and economic development.

Dr. Sanders will continue to hold the rank of Professor, College of Engineering, Urbana-Champaign, on indefinite tenure, on an academic year service basis, on zero percent time, non-salaried.
