Action: Approve Appointment of CEO HealthCare System, Chicago

Funding: State Appropriated Funds

The Chancellor at Chicago has recommended the appointment of John J. DeNardo, currently Executive Director, University of Illinois Hospital and Clinics; and Associate Vice Chancellor for Health Affairs, University of Illinois at Chicago, as CEO, HealthCare System, Chicago, non-tenured, on a twelve-month service basis, on 100 percent time, at an annual salary of \$377,500, beginning August 1, 2005 ~~September 12, 2005~~.

Mr. DeNardo will assume this new position in consequence of the administrative reorganization of health care services and suspension of the position of Vice Chancellor for Health Affairs.

The board action recommended in this item complies in all material respects with applicable State and federal laws, University of Illinois *Statutes*, *The General Rules Concerning University Organization and Procedure*, and Board of Trustees policies and directives.
