APPOINT DEAN, COLLEGE OF APPLIED HEALTH SCIENCES, CHICAGO

Action: Appoint Dean, College of Applied Health Sciences

Funding: State Appropriated Funds

The Vice President, University of Illinois, and Chancellor, University of Illinois at Chicago has recommended the appointment of Bo Fernhall, presently Professor, Department of Kinesiology and Community Health, College of Applied Health Sciences, University of Illinois at Urbana-Champaign, as Dean, College of Applied Health Sciences at Chicago, non-tenured, on a twelve-month service basis, on 100 percent time, at an annual salary of \$176,000 (equivalent to an annual nine-month base salary of \$144,000 plus two-ninths annualization of \$32,000) and an administrative increment of \$74,000, for a total annual salary of \$250,000, beginning on October 1, 2011. In addition, Dr. Fernhall will be appointed to the rank of Professor of Kinesiology and Human Nutrition, College of Applied Health Sciences, on indefinite tenure on an academic year service basis on zero percent time.

Dr. Fernhall will replace Charlotte A. Tate, who has served as Dean of the College of Applied Health Sciences since April 1999 and will be returning to the faculty as of August 16, 2011. Glenn Tsutomu Fujiura will be appointed as Interim Dean Designate for the period August 16, 2011, through September 30, 2011. The Board action recommended in this item complies in all material aspects with applicable State and federal laws, University of Illinois *Statutes, the General Rules Concerning University Organization and Procedure,* and the Board of Trustees policies and directives.

This recommendation is made with the advice of a search committee.¹

recommendation.
