## **ROLL CALL**

INCREASE PROJECT BUDGET, APPROVE RENAMING, AND AWARD CONSTRUCTION CONTRACT FOR BRUCE NESBITT AFRICAN AMERICAN CULTURAL CENTER, URBANA

**Action**: Increase Project Budget, Approve Renaming, and Award Construction

Contract for Bruce Nesbitt African American Cultural Center

**Funding**: Auxiliary Facilities System Revenue Bonds and Institutional Funds

Operating Budget

In September 2015, the Bruce Nesbitt African American Cultural Center project was approved with a budget of \$4.9 million. In May 2017, an additional \$600,000 was approved based on the schematic design. Bids were received in October 2017 and additional funds are needed to support the award of contracts. In order to complete the project, it is necessary to increase the project budget by \$400,000.

Accordingly, the Chancellor, University of Illinois at Urbana-Champaign, and Vice President, University of Illinois with the concurrence of the appropriate administrative officers recommends that the Board approve an increase in the project budget to \$5.9 million, an increase of \$400,000.

The Chancellor, University of Illinois at Urbana-Champaign, and Vice President, University of Illinois with the concurrence of the appropriate administrative officers recommends approval of the renaming of the Bruce Nesbitt African American Cultural Center, as the Bruce D. Nesbitt African American Cultural Center, in honor of Mr. Nesbitt's legacy and many contributions to the University and to memorialize this innovative facility in central campus.

Mr. Nesbitt became the director of the African-American Cultural Program in 1974 where he remained for twenty-two years. He is well-known and respected for his many contributions throughout campus and the Champaign and Urbana communities, working with students and young people and will have an impact for generations to come. Mr. Nesbitt passed away June 20, 2000.

Bids for construction work have been solicited and for the project to proceed, the Chancellor, University of Illinois at Urbana-Champaign, and Vice President, University of Illinois with the concurrence of the appropriate administrative officers, recommends that the following contract<sup>1</sup> be awarded. Competitive bidding procedures in accordance with the Illinois Procurement Code were followed; and the award is to the lowest responsible bidder on the basis of its base bid plus the acceptance of indicated alternates<sup>2</sup>:
