## APPOINT INTERIM DEAN, COLLEGE OF DENTISTRY, CHICAGO

Action: Appoint Interim Dean, College of Dentistry

Funding: State Appropriated Funds

The Chancellor, University of Illinois at Chicago, and Vice President, University of Illinois has recommended the appointment of George William Knight, presently Associate Professor of Restorative Dentistry, Associate Professor, Dental Clinics, and Executive Associate Dean, College of Dentistry, as Interim Dean, College of Dentistry, non-tenured, on a twelve-month service basis, on 100 percent time, at an annual salary of \$199,720, and an administrative increment of \$95,280, beginning January 24, 2014, for a total annual salary of \$295,000.

In addition, he will continue to serve as Executive Associate Dean, College of Dentistry, non-tenured, on a twelve-month service basis, on zero percent time, nonsalaried, effective December 16, 2013; Associate Professor of Restorative Dentistry, College of Dentistry, on a twelve-month service basis, on indefinite tenure, on zero percent time, non-salaried, effective December 16, 2013; and Associate Professor of Restorative Dentistry, College of Dentistry, non-tenured, on a twelve-month service basis, on zero percent time, non-salaried, effective December 16, 2013. Dr. Knight was appointed to serve as Interim Dean Designate under the same conditions and salary arrangement beginning December 16, 2013. Dr. Knight will succeed Bruce S. Graham, who has served as Dean since April 2000, and who will continue as Professor of Restorative Dentistry, College of Dentistry.

This recommendation is made in consultation with the Executive Committee, Heads, and other senior leadership in the College.

The Board action recommended in this item complies in all material respects with applicable State and federal laws, University of Illinois *Statutes, the General Rules Concerning University Organization and Procedure,* and the Board of Trustees policies and directives.

The Vice President for Academic Affairs concurs with this recommendation.
