APPOINT VICE CHANCELLOR FOR STUDENT AFFAIRS, URBANA

Action: Appoint Vice Chancellor for Student Affairs

Funding: State Appropriated Funds

The Chancellor, University of Illinois at Urbana-Champaign, and Vice President, University of Illinois recommends the appointment of Danita M. Brown Young, presently Vice Provost for Student Affairs and Dean of Students, University of Minnesota-Twin Cities, Minneapolis, as Vice Chancellor for Student Affairs, Urbana, non-tenured, on a twelve-month service basis, on 100 percent time, at an annual salary of \$279,500, beginning August 7, 2017.

Dr. Brown Young succeeds C. Renée Romano, who served in the position from July 1, 2006, until her retirement on May 15, 2017. Transitional leadership has been provided by Kenneth T. Ballom.

The Board action recommended in this item complies in all material respects with applicable State and federal laws, University of Illinois *Statutes*, *The General Rules Concerning University Organization and Procedure*, and Board of Trustees policies and directives.

This recommendation is made with the advice of a search committee.¹
