APPOINT INTERIM DEAN, COLLEGE OF BUSINESS AND MANAGEMENT, SPRINGFIELD

Action: Appoint Interim Dean, College of Business and Management

Funding: State Appropriated Funds

The Chancellor, University of Illinois at Springfield, and Vice President, University of Illinois recommends the appointment of James Ermatinger, currently Professor of History and Dean, College of Liberal Arts and Sciences, University of Illinois at Springfield, as Interim Dean, College of Business and Management, nontenured, on a twelve-month service basis, with an annual administrative increment of \$24,000 effective March 16, 2018. Dr. Ermatinger served as Interim Dean Designate with the aforementioned administrative increment effective February 1, 2018.

In addition, Dr. Ermatinger will continue to serve as Professor of History and Dean, College of Liberal Arts and Sciences, on indefinite tenure, on an academic year service basis, on 100 percent time, with an annual salary of \$165,785, effective August 16, 2017. He will also continue to receive a \$2,000 per month stipend for the temporary assignment of developing and organizing the working plans for the Center for Lincoln Studies. His total annual compensation is \$213,785.

Dr. Ermatinger succeeds Dean Ronald McNeil, who has served as Dean of the College since May 17, 2002, through December 31, 2017. Dean McNeil retired December 31, 2017.
