APPOINT INTERIM VICE CHANCELLOR FOR ACADEMIC AFFAIRS AND PROVOST, SPRINGFIELD

Action: Appoint Interim Vice Chancellor for Academic Affairs and Provost

Funding: State Appropriated Funds

The Chancellor, University of Illinois at Springfield, and Vice President, University of Illinois recommends the appointment of James W. Ermatinger, presently Professor, Department of History; Dean, College of Liberal Arts and Sciences; and Interim Dean, College of Public Affairs and Administration, University of Illinois at Springfield, as Interim Vice Chancellor for Academic Affairs and Provost, non-tenured, on a twelve-month service basis, on 100 percent time, at a total annual salary of \$193,000, beginning June 1, 2016. In addition, Dr. Ermatinger will continue to hold the rank of Professor of History, on indefinite tenure, on an academic year basis, on zero percent time, non-salaried, effective August 16, 2016.

Dr. Ermatinger succeeds Dr. Patricia L. Pardie, who will retire May 31, 2016.
