ROLL CALL

PURCHASE RECOMMENDATIONS

The "Purchase Recommendations and Renewal Options" are presented by university, and a Summary from "Appropriated Funds" (i.e., from State appropriations to the university) and from "Institutional Funds" is included. The latter term is used here to designate funds received by the university under contracts with the United States Government; contracts with private corporations and other organizations, from foundation grants, and grants from corporations and other donors; and university revolving funds authorized by law. The Summary also indicates a total amount by university.

The Board action recommended in this item complies in all material respects with applicable State and federal laws, University of Illinois Statutes, The General Rules Concerning University Organization and Procedure, and Board of Trustees policies and directives.

The Assistant Vice President for Procurement Services has proposed and the Vice President, Chief Financial Officer recommends the following purchases. Unless otherwise specified, the purchase in each case is recommended on the basis of the lowest acceptable bid.

The President of the University concurs.

This purchase is exempt from the usual selection processes of the Procurement Code because the procurement expenditure is necessary to perform sponsored research and other sponsored activities under grants and contracts funded by the sponsor or by sources other than State appropriations per 30 ILCS 500/1-13(b)(8). This is a one-time purchase.

Atom probe tomography is a unique technique for chemical analysis of material providing a three-dimensional spatial distribution of chemical species with exact atomic location. The instrument (LEAP 5000XS) is capable of providing a 3-dimensional spatial distribution of chemical species in a material sub-nanometer resolution.

The proposed purchase of a LEAP 5000XS will allow investigators to perform analysis on campus rather than having to travel to other institutions across the country. The technique will have a tremendous impact on several research programs across campus, such as, but not limited to, studies of nuclear materials, 3D analysis of heterostructures, quantum dots, self-adapting materials via non-equilibrium nanostructuration, the coupling of plasticity, and chemistry at nanoscale.

Negotiations were successful in securing additional academic discounts resulting in a 34% (\$1,158,300) discount from the suggested retail price.
