APPOINT INTERIM DEAN, COLLEGE OF PUBLIC AFFAIRS AND
ADMINISTRATION, SPRINGFIELD

Action: Approve Appointment of Interim Dean, College of Public Affairs and Administration

Funding: State Appropriated Funds

The Vice President, University of Illinois and Chancellor, University of Illinois at Springfield has recommended the appointment of William H. Miller, currently Professor and Department Chair, Department of Public Administration, as Interim Dean, College of Public Affairs and Administration, non-tenured, on a twelve-month service basis, with a monthly administrative increment of \$1,800, beginning January 1, 2013, through June 30, 2013.

Dr. Miller will continue to hold the rank of Professor of Public Administration, on indefinite tenure, on an academic year basis, on 100 percent time, at an annual salary of \$95,756, effective August 16, 2012; and Department Chair, Department of Public Administration, non-tenured, on an academic year service basis, with a summer administrative increment of \$10,640, for a total annual salary of \$117,196.

Dr. Miller succeeds Pinky S. Wassenberg, who has served as Dean since 2006, and who plans to return to the faculty as Professor of Political Science on January 1, 2013.

The Board action recommended in this item complies in all material respects with applicable State and federal laws, University of Illinois *Statutes, The General Rules Concerning University Organization and Procedure*, and Board of Trustees policies and directives.

The Vice President for Academic Affairs concurs.
