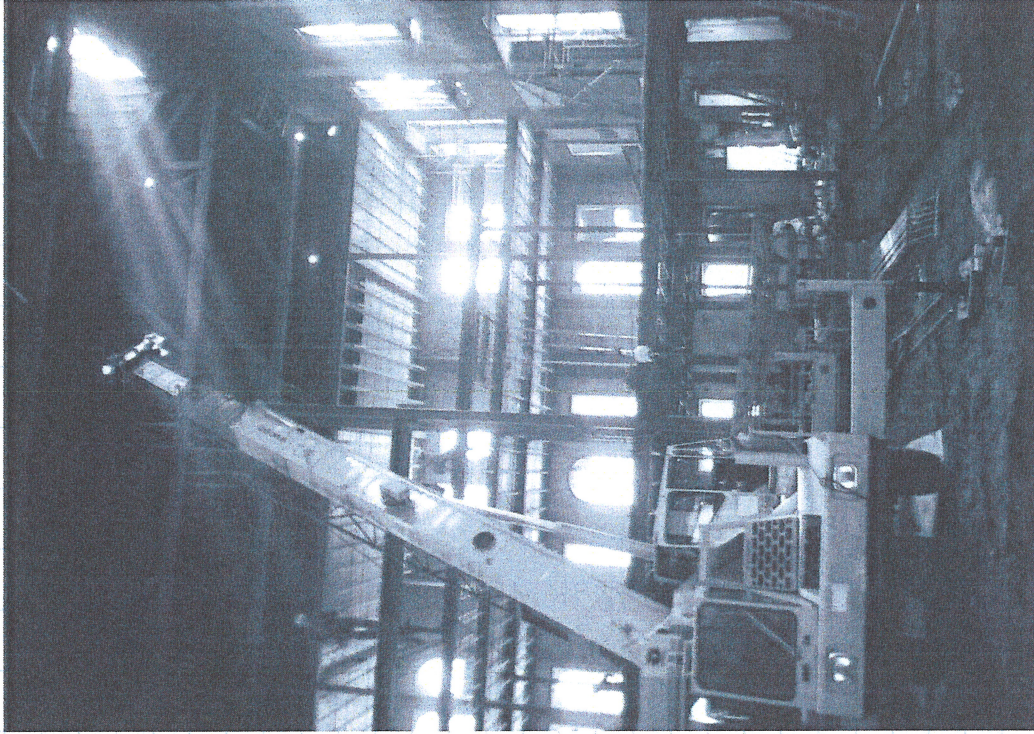

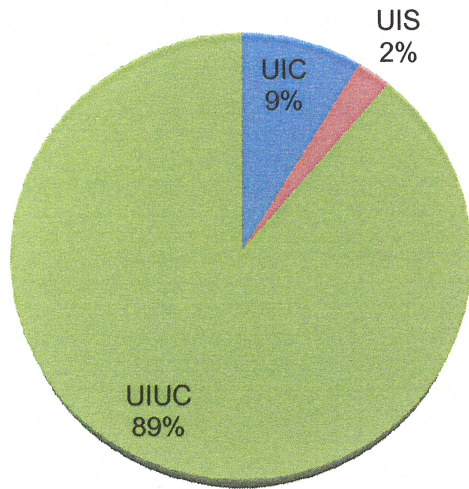

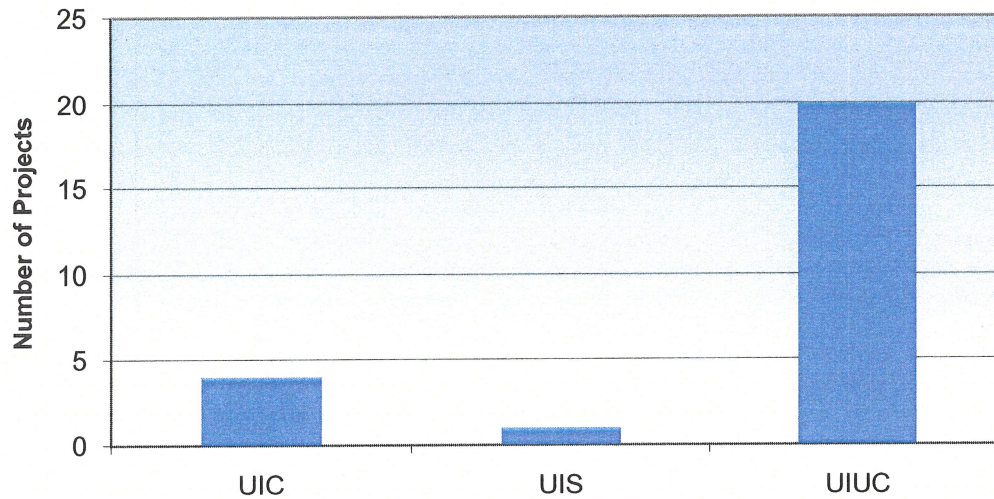


Capital Expenditures Per Campus

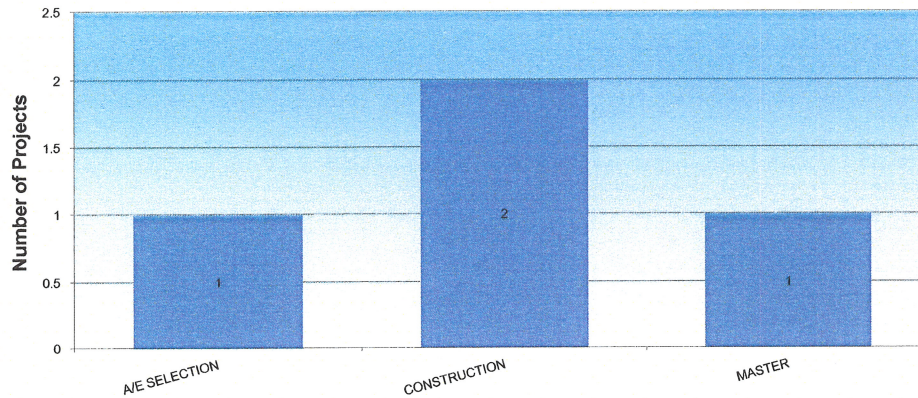
UIC Active Projects by Funding Source



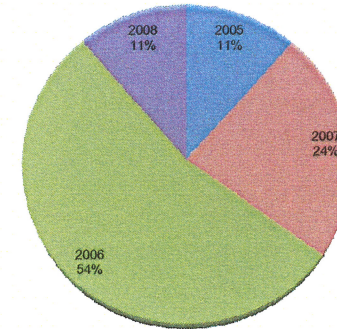
UIC Active Projects by Type

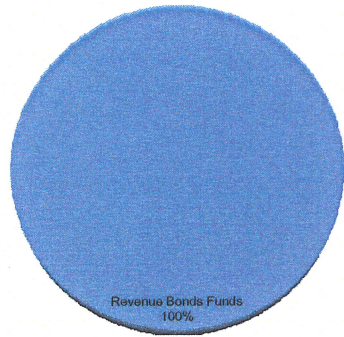

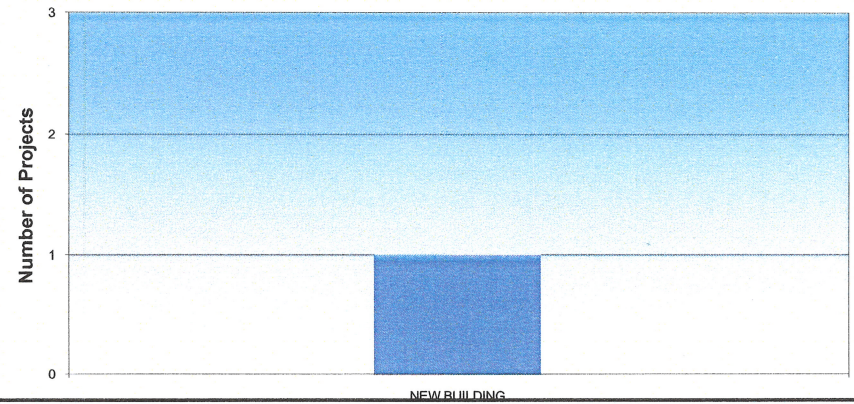

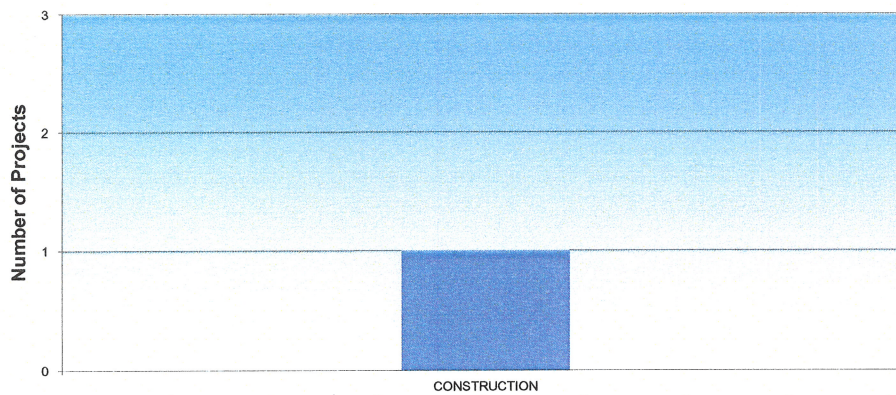
UIS Active Projects by Funding Source



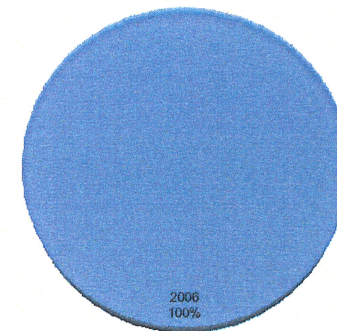
UIS Active Projects by Type
