Meeting of September 6, 1913.

Pursuant to the adjournment taken at the meeting of August 26, 1913, the Board of Trustees of the University of Illinois met in the office of the Governor, at Springfield, on Saturday, September 6, 1913, beginning at 10 A.M.

The following members were present: Mr. Abbott, Mr. Blair, Mr. Dunne, Mrs. Evans, Mr. Hoit, Mr. Trevett. President James and Dr. Eugene Davenport, Dean of the College of Agriculture, were present.

APPROVAL OF PURCHASE OF LAND.

President Abbott stated that the first matter to come before the meeting was the question of the purchase of land, which was ordered by the Board of Trustees at its meeting of July 23, 1913 (pp. 606 and 625), but the consummation of which had been delayed at the request of the Governor until it could be further considered.

Dean Davenport was heard in regard to this matter, and showed that the piece of land in question is the only piece of land contiguous to the present campus which, in its character and in the way it lies, is suitable for the purpose for which this land is especially desired, namely, for experimentation in horticulture—all other contiguous land being corn land and not orchard land. It appeared that a special committee appointed by the Illinois State Horticultural Society, consisting of five leading horticulturists from different parts of the State had looked over the entire region about the University within a radius of five miles, and had urgently recommended the purchase of this particular tract, even stating that if it could not be had at the price which it is proposed to pay, it ought to be purchased at double that price rather than to suffer the loss to the cause of scientific investigation in horticulture in this State that would result from the failure to secure the one tract of land suitable for this purpose in the immediate neighborhood of the University.

An extended discussion followed. In the course of this discussion it appeared that by comparison with the prices which have been offered by other parties for portions of the land in question, and by comparison with the prices which have been paid for other similar tracts in the neighborhood of the University, the prices which it is proposed to pay for this land are not excessive.

RESOLUTION.

President Abbott then offered the following resolution:

President Abbott then offered the following resolution:

WHEREAS, The Board of Trustees of the University of Illinois on July 2, 1913, by unanimous vote referred the question of the purchase of land to the Finance Committee of the board for consideration and report; and,

WHEREAS, The said Finance Committee reported to the said Board of Trustees on July 23, 1913, recommending the purchase of one hundred sixty acres of land known as the "Busey tract," lying immediately east of property now owned by the University, at the price of one thousand dollars (\$1,000) per acre, and the purchase of an additional one hundred sixty acres lying immediately south of said "Busey tract," at the price of six hundred dollars (\$600) per acre; and,

WHEREAS, The Board of Trustees, on July 23, 1913, by unanimous vote, eight members being present, authorized the officers of the board to close the purchase of the tracts of land recommended by the Finance Committee for purchase; and,

WHEREAS, Vouchers were issued by the Comptroller of the University in payment of said purchase money, the titles for the several tracts having been

approved by Savage & Woods, examining attorneys, and the State Auditor was requested to issue his warrants for the several sums; and,

WHEREAS, Before the warrants were issued the President of the Board of Trustees requested the State Auditor not to issue the warrants until further notice, because of a request from the Governor of the State that the transaction be not completed until he had had an opportunity to acquaint himself with the details of the purchase, in order to satisfy himself that the price to be paid was not excessive; therefore, be it

Resolved, That the State Auditor be requested to issue his warrants immediately for the said sums, in payment of vouchers presented for the properties acquired; since the Board of Trustees is convinced that the acquisition of said properties, consisting altogether of three hundred twenty acres, is desirable and necessary for the work of the University, and that the price agreed upon is not an excessive price considering the location of the properties and the prices actually paid for similar properties in the neighborhood within the last four or five years.

On motion of Mrs. Evans, the foregoing resolution was adopted; all the

On motion of Mrs. Evans, the foregoing resolution was adopted; all the members present voting "aye," with the exception of Governor Dunne, who asked to be excused from voting, for the reason that he had not been able to make a personal investigation of the character and value of the land in question and other land in the neighborhood of the University. afternoon session Dr. Montgomery recorded his vote on the foregoing resolution as "aye.")

MATTERS PRESENTED BY THE PRESIDENT OF THE UNIVERSITY.

President James presented the following matters for consideration:

IMPROVEMENTS IN MECHANICAL ENGINEERING SHOPS.

(1) A request from Professor James M. White, Supervising Architect, that an appropriation of three thousand dollars (\$3,000) be made for improvements in the shops of the Department of Mechanical Engineering.

On motion of Mr. Blair, this request was approved, and the appropriation of three thousand dollars (\$3,000) was made; the vote being as follows: Ayes, Mr. Abbott, Mr. Blair, Mr. Dunne, Mrs. Evans, Mr. Hoit, Mr. Montgomery (recorded at the afternoon session), Mr. Trevett; noes, none; absent, Mrs. Busey, Mrs. Henrotin, Mr. Meeker, Mr. Moore, Miss Watson.

PURCHASE OF THE RHINEHART TRACT.

(2) A recommendation that the officers of the board be authorized to close the purchase of the ten acres known as the "Rhinehart tract," lying between Sixth Street and the Illinois Central Railroad immediately south of the land recently acquired by the Athletic Association, and that an appropriation of eight thousand dollars (\$8,000\$) or as much thereof as may be necessary be made for this purpose; and, further, that this tract, or so much thereof as may be necessary, be assigned to the use of the Department of Botany until further notice, with the provision that no plantings shall be made in this tract that would be an entire loss, or should require more than two years for their removal without loss, should the tract be used later for other purposes.

Upon motion of Mr. Hoit, this recommendation was approved, the vote being as follows: Ayes, Mr. Abbott, Mr. Blair, Mr. Dunne, Mrs. Evans, Mr. Hoit, Mr. Montgomery (recorded at the afternoon session), Mr. Trevett; noes, none; absent, Mrs. Busey, Mrs. Henrotin, Mr. Meeker, Mr. Moore, Miss Watson.

PURCHASE OF AUGUSTUS PROPERTY APPROVED.

(3) A recommendation that the board approve the action of the President of the Board of Trustees in ordering the purchase of the land known as the "Augustus property," a tract of thirteen acres lying between the present campus and the present south farm, for the sum of twenty thousand dollars (\$20,000); it having been necessary to make this purchase at the time when President Abbott ordered it made, July 31, 1913, in order to take advantage of an option which was about to expire and which could not have been renewed on equally favorable terms.

On motion of Mr. Trevett, it was voted to approve the action of the president of the board in ordering this purchase, and to make the requisite appropriation of twenty thousand dollars (\$20,000). The vote was as follows: Ayes, Mr. Abbott, Mr. Blair, Mr. Dunne, Mrs. Evans, Mr. Hoit, Mr. Montgomery (recorded at the afternoon session), Mr. Trevett; noes, none; absent, Mrs. Busey, Mrs. Henrotin, Mr. Meeker, Mr. Moore, Miss Watson.

FURTHER PURCHASE OF LAND.

(4) A recommendation that the board authorize the acquisition of further land suitable for sites for a zoological laboratory, a botanical laboratory, an insectary, a University storehouse, a School of Education Building, and a women's residence hall; that reasonable prices be tendered to the owners of the sites that may be selected; and that if these prices be not accepted the Counsel of the University be instructed to initiate proceedings for the acquisition of the property by condemnation.

Governor Dunne suggested the following resolution on the subject of this recommendation: That the Finance Committee be authorized to negotiate for the purchase of sites for a zoölogical laboratory, a botanical laboratory, an insectary, a University storehouse, a school of education building, and a women's residence hall at reasonable prices, and in case options can not be secured at reasonable prices, to commence condemnation proceedings for the acquirement thereof.

On motion of Mr. Trevett, the foregoing resolution suggested by Governor Dunne was adopted, the vote being as follows: Ayes, Mr. Abbott, Mr. Blair, Mr. Dunne, Mrs. Evans, Mr. Hoit, Mr. Montgomery (recorded at the afternoon session), Mr. Trevett; noes, none; absent, Mrs. Busey, Mrs. Henrotin, Mr. Meeker, Mr. Moore, Miss Watson.

APPOINTMENT OF DIRECTOR OF PHOTOGRAPHIC LABORATORIES.

(5) A recommendation that the President of the University be given authority to appoint Mr. Arthur G. Eldredge to be Instructor in Photography and Director of the Photographic Laboratories, at a salary of three thousand dollars (\$3,000) per annum, beginning September 1, 1913, or as soon thereafter as he may report for service in Urbana.

On motion of Mrs. Evans, this recommendation was approved, the vote being as follows: Ayes, Mr. Abbott, Mr. Blair, Mr. Dunne, Mrs. Evans, Mr. Hoit, Mr. Montgomery (recorded at the afternoon session), Mr. Trevett; noes, none; absent, Mrs. Busey, Mrs. Henrotin, Mr. Meeker, Mr. Moore, Miss Watson.

ADJUSTMENT IN THE SALARY OF MR. W. A. CHASE.

(6) A recommendation that the salary of Mr. William A. Chase as Lecturer in Accountancy and Commercial Law, on part time, for the academic year 1913-14, be fixed at twenty-four hundred dollars (\$2,400), instead of two thousand dollars (\$2,000) as was approved by the Executive Committee on July 23, 1913, (page 628); the recommendation that this salary be fixed at two thousand dollars having been based on incomplete information.

On motion of Mr. Blair, this recommendation was approved, the vote being as follows: Ayes, Mr. Abbott, Mr. Blair, Mr. Dunne, Mrs. Evans, Mr. Hoit, Mr. Montgomery (recorded at the afternoon session), Mr. Trevett; noes, none; absent, Mrs. Busey, Mrs. Henrotin, Mr. Meeker, Mr. Moore, Miss Watson.

CORPORATION TAX FOR THE COLLEGE OF PHYSICIANS AND SURGEONS.

(7) A recommendation from Dean O. A. Harker, Legal Counsel of the University, that the comptroller be authorized to pay the corporation tax assessed against the College of Physicians and Surgeons for the year 1912, and that an appropriation of two hundred fifty dollars (\$250) or as much thereof as may be necessary, be made for this purpose.

On motion of Mrs. Evans, this recommendation was approved, the vote being as follows: Ayes, Mr. Abbott, Mr. Blair, Mr. Dunne, Mrs. Evans, Mr. Hoit, Mr. Montgomery (recorded at the afternoon session), Mr. Trevett; noes, none; absent, Mrs. Busey, Mrs. Henrotin, Mr. Meeker, Mr. Moore, Miss Watson.

PAVING OF BURRILL AVENUE AND THE EAST DRIVEWAY.

(8) A recommendation from Professor James M. White, Supervising Architect, that the sum of six thousand dollars (\$6,000) be appropriated for the paving of Burrill Avenue from Green Street as far south as the Auditorium with tarvia, and that the east driveway be laid out according to a plan submitted and be paved as far south as the Auditorium with the same material, and that elms be planted on both sides of it.

This recommendation was referred to the Committee on Buildings and Grounds for consideration and report.

PRINTING OF PROCEEDINGS AT THE DEDICATION OF LINCOLN HALL.

(9) A recommendation that the President of the University be authorized to make an arrangement with the Houghton Mifflin Company, of Boston, Mass., for the publication of the addresses given at the dedication of Lincoln Hall, with such an account of the proceedings as may be deemed desirable, and that an appropriation of eight hundred fifty dollars (\$850) be made for this purpose.

On motion of Mr. Blair, this recommendation was approved, the vote being as follows: Ayes, Mr. Abbott, Mr. Blair, Mr. Dunne, Mrs. Evans, Mr. Hoit, Mr. Montgomery (recorded at the afternoon session), Mr. Trevett; noes, none; absent, Mrs. Busey, Mrs. Henrotin, Mr. Meeker, Mr. Moore, Miss Watson.

CO-OPERATION WITH THE EUGENICS RECORD OFFICE OF THE AMERICAN BREEDERS ASSOCIATION.

(10) A communication from Mr. H. H. Laughlin, Superintendent of the Eugenics Record Office of the American Breeders' Association, suggesting an arrangement for cooperative work between his office and the University of Illinois in investigating the data collected by Mr. Matthews, of Onarga, concerning the life histories of children of criminal parents and in preparing this data for publication if it should prove to be of sufficient value.

On motion of Mr. Blair, it was voted that the President of the University be authorized to investigate this proposition, that he be authorized to enter into such an arrangement as is proposed by Mr. Laughlin if, in his judgment, the results to be obtained promise to be of sufficient value, and that an appropriation of one thousand dollars (\$1,000), or as much thereof as may be necessary, be made for this purpose. The vote was as follows: Ayes, Mr. Abbott, Mr. Blair, Mr. Dunne, Mrs. Evans, Mr. Hoit, Mr. Montgomery (recorded at the afternoon session), Mr. Trevett; noes, none; absent, Mrs. Busey, Mrs. Henrotin, Mr. Meeker, Mr. Moore, Miss Watson.

OFFER OF \$1000 FROM THE WOMAN'S BOARD OF MISSIONS OF THE INTERIOR.

(11) A letter from Miss Florence Starr of the Executive Committee of the Woman's Board of Missions of the Interior of the Congregational Church, asking that the Board of Trustees accept again the sum of one thousand dollars (\$1,000), which was formerly given to the College of Medicine for the establishment of a scholarship, but which was repaid when the University closed its College of Medicine on July 1, 1912, and that the board re-establish the scholarship.

No action was taken with reference to this matter.

ENTRANCE REQUIREMENT OF THE SCHOOL OF PHARMACY RAISED.

(12) A recommendation from the Advisory Board of the School of Pharmacy that the entrance requirements of the school be advanced to two years in an accredited high school or the full equivalent thereof, this requirement to be effective for the school year 1914-15.

On motion of Mr. Blair, this recommendation was approved.

LEAVE OF ABSENCE FOR PROFESSOR HOPKINS.

(13) A letter from Dr. Eugene Davenport, Dean of the College of Agriculture, transmitting a request from Dr. C. G. Hopkins, Professor of Agronomy, for a leave of absence without pay for one year beginning November I, 1913, to enable him to accept the position of Director with the Southern Settlement and Development Association; with the recommendation that this request of Dr. Hopkins be granted and that Dr. L. H. Smith, Professor of Plant Breeding, be appointed Acting Head of the Department of Agronomy, for one year beginning November 1, 1913, at a salary of thirty-five hundred dollars (\$3,500) for the year.

On motion of Mr. Trevett, this request was granted.

MORTGAGE TO CHICAGO BOARD OF EDUCATION PAID.

(14) A letter from Professor George E. Frazer, Comptroller, calling attention to the fact that a mortgage note of ten thousand dollars (\$10,000) with interest from July 1, 1913, will be due to the Chicago Board of Education on November 1, 1913; with the recommendation that the comptroller be authorized to pay this note with accrued interest, and that an appropriation of ten thousand dollars

(\$10,000) plus the necessary sum for interest to November 1 be made, to be charged to the proceeds of fees from the medical students.
