MEETING OF THE BOARD OF TRUSTEES

OF THE

UNIVERSITY OF ILLINOIS

January 16, 1920

A special meeting of the Board of Trustees of the University of Illinois was held at the Blackstone Hotel, in Chicago, at 10 o'clock a. m. on Friday, January 16, 1920, pursuant to the following notice, which was sent out by the Secretary on January 5, 1920:

On the call of the President, Mr. Robert F. Carr, there will be a special meeting of the Board of Trustees of the University of Illinois at ten o'clock a. m. on Friday, January 16, 1920, at the Blackstone Hotel, in Chicago, to consider matters submitted by the President of the University and the Committees of the Board, and such other matters as may be duly submitted.

The following members were present: President Carr, Mr. Abbott Mr. Blair, Mrs. Blake, Mrs. Busey, Mrs. Evans, Mr. Herbert, Mr. Hoit.

Acting President Kinley was present; also, during part of the day, Professor J. M. White, Supervising Architect, and Messrs. Holabird, Roche, and Root, of the firm of Holabird and Roche, Consulting Architects.

MINUTES APPROVED

The Secretary presented the minutes of the meeting of December 9, 1919, and the adjourned session of December 13, 1919.

On motion of Mrs. Blake, the minutes were approved as printed on pages 641 to 662 above.

HISTORY OF THE CAMPUS PLAN

Professor White presented a history of the Campus Plan, illustrated by a complete set of drawings and sketches.

On motion of Mr. Blair, it was voted to extend the thanks of the Board to Professor White for his excellent presentation of the history of the development of the Campus Plan, and to refer the material collected to the Consulting Architects for their consideration.

At this point, at 12:45 p.m., a recess was taken for luncheon.

AFTERNOON SESSION, JANUARY 16, 1920

When the Board convened after the recess on the afternoon of January 16, 1920, the same persons were present as during the morning session, and also Mr. R. R. Ward, a member of the Board.

HORTICULTURE BUILDING

On motion of Mrs. Busey, the Consulting Architects were requested to have the plans for the Horticulture Building prepared so that bids could be asked for on March 9, 1920; such plans to be drawn by the architects in conference with the department, to provide tor a building to cost not more than \$100,000.

CAMPUS PLAN

On motion of Mr. Blair, the President of the Board was authorized to appoint a commission of members of the Board, faculty, or alumni, to advise with the architects in consideration of the development of the Campus Plan and to report to the Board.

MATTERS SUBMITTED BY ACTING PRESIDENT KINLEY

The Board considered the following matters submitted by the Acting President of the University.

ASSISTANT DEAN OF THE COLLEGE OF COMMERCE

(1) A recommendation from Dean C. M. Thompson that Mr. A. C. Littleton, Associate in Accountancy, be appointed Assistant Dean of the College of Commerce and Business Administration, beginning immediately and continuing until July 1, 1920, with compensation of \$150, in addition to Mr. Littleton's present salary of \$2400 a year.

On motion of Mr. Blair, this appointment was made, by the following vote: Ayes, Mr. Abbott, Mr. Blair, Mrs. Blake, Mrs. Busey, Mr. Carr, Mrs. Evans, Mr. Herbert, Mr. Hoit, Mr. Ward; no, none; absent, Mr. Lowden, Mr. Trimble.

LEAVE OF ABSENCE FOR DR. B. O. SIPPY

(2) A recommendation that Dr. B. O. Sippy, of the College of Dentistry, be given leave of absence without pay, for two months beginning February 1, 1920, to take advanced study in the University of California.

This recommendation was approved.

REFUND OF FEES IN THE CHICAGO DEPARTMENTS

(3)A recommendation that the Board adopt for the Chicago departments the following plan for the refund of all fees other than matriculation and registration fees, no part of which will be refunded:

Withdrawal within 10 days after beginning of instruction-refund total amount of fees paid (except matriculation and registration fees).

Withdrawal after 10 days, and before expiration of one month-refund threefourths of amount of fees paid.

Withdrawal after one month and before expiration of two months-refund onehalf of amount of fees paid.

Withdrawal after two months and before expiration of three months-refund one-fourth of amount of fees paid.

After the expiration of three months, no part of the fees paid will be refunded.

On motion of Mr. Blair, this recommendation was approved.

CONFERENCE OF COLLEGE PRESIDENTS

The following statement: (4)

Occasionally in the past ten years the University has invited the presidents of the smaller colleges of the State to the University for conference on matters of common interest. These meetings have always been helpful in cementing our friendly relations with the colleges, and in helping us establish and maintain proper standings for transfer of credits, and especially for graduate work. The Dean of the Graduate School and others, including myself, feel that the time has come for another such conference. Accordingly I ask authority to call such a conference, the University to pay the necessary traveling and entertainment expenses of the delegates, and request that the sum of \$300, or so much thereof as may be necessary, be appropriated for this pur-pose, chargeable to the Graduate School funds.

On motion of Mr. Abbott, this conference was authorized.

SUMMER SESSION SALARIES

(5) A recommendation that the following scale of summer session salaries be adopted, to be effective for 1920:

GIFT OF GERMAN ANTI-TANK RIFLE

(6) The following letter from Captain James M. Farrin, Esq.

From: Captain James M. Farrin, Eng. To: President David Kinley, University of Illinois

Subject: Gun

Upon leaving the University to return to civil life, I wish to present to the University of Illinois as a beginning of a Military Museum, a German anti-tank rifle which I picked up at the town Buzancy. This type was called elephant gun. If the University accepts this gun, I desire that it be on condition of permanently

and properly preserving it.

INSURANCE ON PAPER AND SOIL MAPS

(7) A recommendation that the Comptroller be authorized to take out insurance on paper and soil maps stored with printers who are doing work under contract with the University, at a cost of not more than \$200 a year.

On motion of Mr. Abbott, this recommendation was approved.

SEMI-CENTENNIAL ALUMNI RECORD-VOLUME II

(8) The following statement:

I have authorized Mr. Carl Stephens to proceed with the compilation of Volume II of the Semi-Centennial Alumni Record (that for the Chicago departments). Mr. Stephens makes the following estimate of the cost of a staff to handle the work, assuming that it can be done in a year:

Mr. Stephens will act as editor and be in general charge of the work, and be responsible to the President of the University and the Board of Trustees.

I recommend that \$2,000.00 be appropriated from the Reserve and Incidental fund to carry this work to June 30, 1920.

ADDITIONAL APPROPRIATION FOR THE DEPARTMENT OF PHYSICAL EDUCATION FOR MEN

(9) A request from the Director of the Department of Physical Education for Men, Mr. George A. Huff, for an additional appropriation of \$1000, to carry on the work for the rest of the year.

On motion of Mrs. Evans, this appropriation was made, by the following vote: Ayes, Mr. Abbott, Mr. Blair, Mrs. Blake, Mrs. Busey, Mr. Carr, Mrs. Evans, Mr. Herbert, Mr. Hoit, Mr. Ward; no, none; absent, Mr. Lowden, Mr. Trimble.

APPROPRIATION FOR SCHOLARSHIPS AND FELLOWSHIPS IN THE GRADUATE SCHOOL FOR THE YEAR 1920-1921

(10) A request from Acting Dean A. H. Daniels of the Graduate School for the usual authority to appoint scholars and fellows in the Graduate School for the year 1920-21, with stipendiums not to exceed a total of \$25,000.

On motion of Mrs. Evans, this appropriation was authorized.

CHICAGO OFFICE

(11) The following statement:

On March 15, 1919, on recommendation of the Comptroller, the Executive Committee authorized the President of the University to lease an office in Chicago for the use of the Trustees of the University, and for the Department of Industrial Education in Chicago, at a rent not to exceed one hundred dollars a month. A lease was secured on Room 528, Continental & Commercial Bank Building, from May 1, 1919, to April 30, 1920, at a monthly rental of \$75.00, or \$900.00 for the year. The Continental & Commercial Bank Building has given notice that a renewal of the lease can be had only on payment of a rental of \$108.75 a month, or \$1305 for the year.

I recommend that the Comptroller be given authority to draw up a new lease on these terms.

RESERVE AND INCIDENTAL FUND

(12) A statement that the Reserve and Incidental Fund on January 12,1920, was \$61,011.63.

This report was received for record.

GIFT FROM U. S. INTERDEPARTMENTAL SOCIAL HYGIENE BOARD

(13) A statement that the University had received a gift of \$3500 from the U. S-Interdepartmental Social Hygiene Board, to be used for experimental work on certain arsenic compounds.

On motion of Mr. Abbott, this gift was accepted for the purposes specified.

CONTRACT FOR STATISTICAL HISTORY

(15) A recommendation from Mr. H. E. Cunningham, Director of the University Press, that the contract for printing the Statistical History of the University (see page 560) be awarded to the Pantagraph Printing and Stationery Company, of Bloomington, Illinois, on the basis of their bid of \$1520 for 1500 books of 224 pages.

On motion of Mr. Blair, this recommendation was approved.

At this point, Mr. Blair withdrew. President Carr, being called from the room, requested Mrs. Evans to preside over the meeting. President Carr returned during the presentation of the next item.

INCREASE OF INCIDENTAL FEE

(16) A statement concerning the advisability of increasing the Incidental Fee, now \$15 a semester.

On motion of Mrs. Blake, the Acting President of the University was requested to submit a statement concerning this matter at the next meeting of the Board.

CONSTITUTIONAL STATUS OF UNIVERSITY

(17) A statement concerning the proposal to submit to the Constitutional Convention an article defining the status of the University.

On motion of Mr. Ward, this matter was referred to the Executive Committee and the Acting President of the University, with power to act.

COMPTROLLER'S REPORT

(18) The report of the Comptroller for the quarter ending December 31, 1919.

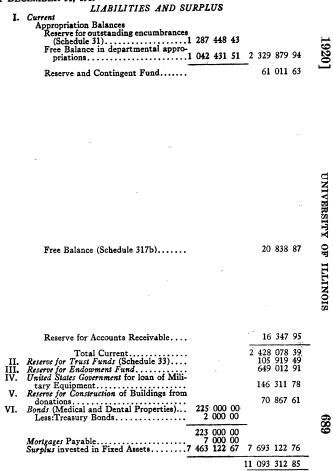
