The January meeting of the Board of Trustees of the University of Illinois was held at the Chicago Professional Colleges, in the Chicago Illini Union Building, 715 South Wood Street, Chicago, Illinois, on Wednesday, January 20, 1960, beginning at 1:30 p.m.

COMMITTEE MEETINGS

Meetings of the Board Committees on General Policy, Buildings and Grounds, and Nonacademic Personnel were held in the forenoon, beginning at 9:00 a.m.

ADDRESS BY DOCTOR EDWARD F. LIS

During the luncheon recess, following Board committee meetings, Dr. Edward F. Lis, Associate Professor of Pediatrics and Director of the Division of Services for Crippled Children, addressed the Board, discussing the program and operations of the Division.

BUSINESS PRESENTED BY THE VICE-PRESIDENT AND PROVOST OF THE UNIVERSITY

In the absence of President David D. Henry, Vice-President and Provost Gordon N. Ray presented the following reports and recommendations.

APPOINTMENT OF ASSOCIATE DEAN OF ADMINISTRATION AT CHICAGO UNDERGRADUATE DIVISION

(1) Upon recommendation of the Executive Dean of the Chicago Undergraduate Division and after consultation with the Executive Dean's Advisory Council, I recommend the appointment of Arthur D. Pickett, Associate Professor of Bio-logical Sciences, as Associate Dean of Administration of the Chicago Undergraduate Division beginning February 1, 1960, at a salary of \$13,000 a year on a twelve-month service basis. He will retain his rank and indefinite tenure as Associate Professor of Biological Sciences.

This will be a new position, made necessary by the increasing administrative load at the Chicago Undergraduate Division.

On motion of Mrs. Watkins, this appointment was approved.

CHAIRMANSHIP OF THE DEPARTMENT OF HISTORY

(2) Professor J. W. Swain, Chairman of the Department of History, will retire

from active service at the end of the current academic year. The Dean of the College of Liberal Arts and Sciences recommends the ap-pointment of Professor Chester G. Starr as Acting Chairman of the Department for one year from September I, 1960, and Professor Norman A. Graebner as Chairman of the Department for two years from September I, 1961. The salaries will be determined when the budgets for 1960-61 and 1961-62 are submitted to the Board for approval.

These appointments are recommended after consultation with the Executive Committee of the Department. The Vice-President and Provost and the Dean of the Graduate College have also been consulted and concur.

Professor Graebner's appointment as Chairman is being deferred for one year on his request. During the past year or two he has assumed numerous responsi-bilities outside the Department of History, including special University service on committees and other assignments, which have interrupted his historical writings, and he desires time off to catch up before taking over the chairmanship. He will be an Associate Member of the Graduate College Center for Advanced Study during 1060-61.

I recommend approval.

On motion of Mr. Swain, these appointments were approved. The Secretary was instructed to send Professor Swain a letter expressing appreciation of the Board of Trustees for his many years of faithful and devoted service to the University.

APPOINTMENT OF PETER R. ELLIOTT AS HEAD FOOTBALL COACH

(3) The Board of Directors of the Athletic Association and the Director of Intercollegiate Athletics recommend the appointment of Peter R. Elliott, formerly Head Football Coach at the University of California at Berkeley, as Head Football Coach at the University of Illinois effective January I, 1960, at a salary of

\$18,000 a year. The Dean of the College of Physical Education will also recommend his appointment as Associate Professor of Physical Education for Men effective September I, 1960, and part of his salary thereafter will be paid from University funds for teaching services. In the meantime, Mr. Ray Eliot, who became Assist-ant Director of Athletics on January 1, 1960, and who is also Associate Professor of Physical Education for Men, will in that capacity complete his teaching assignment for the academic year 1959-60.

After consultation with all members of the Board of Trustees and securing their approval, the appointment was announced on December 22, 1959, and is now submitted with the President's recommendation for formal approval.

On motion of Mr. Herrick, seconded by Mr. Pogue, this appointment was approved.

APPOINTMENTS TO THE FACULTY

(4) The following new appointments to the faculty of the rank of Assistant Professor and above, and involving tenure, have been approved since the previous meeting of the Board of Trustees.

APPOINTMENT TO THE INSTITUTE OF LABOR AND INDUSTRIAL RELATIONS ADVISORY COMMITTEE

(5) The Director of the Institute of Labor and Industrial Relations recommends the appointment of Mr. John Meade, Vice-President and Director of Industrial Relations of Fansteel Metallurgical Corporation, North Chicago, Illinois, as a management representative on the Institute's Advisory Committee for a term of three years beginning September 1, 1959, to fill a vacancy on that Committee. Mr. Meade has had extensive government and industry experience in the field of industrial relations.

ADMISSION OF TRANSFER STUDENTS

(7) The three Senates recommend that the regulations governing the admission of students transferring from other colleges or universities be amended to read as follows, the change to become effective September 1, 1960:

A person who has attended another college or university of recognized standing is considered for admission to the University of Illinois on presenting (1) a transcript of his college record showing honorable dismissal from the institution from which he comes, and (2) an official statement of his preparatory school work.

General University requirements for admission by transfer in terms of the grading system of the University of Illinois, are as follows:

- 1. With more than forty semester hours of academic credit, a minimum of
 - a. 3.0 (C) total average, including all courses passed or failed;
 - b. 3.0 (C) averages for the applicant's last semester (with a minimum of the last twelve semester hours taken by a transfer student to be used in determining the last semester average; furthermore, if the last twelve semester hours bridge two or more semesters, quarters, or summer sessions of study, the entire semester, quarter, or summer session of study in which the twelfth hour falls should be included in the average); or approval of the applicant's petition by the dean of the college concerned, for his admission on probationary status.
- 2. With forty semester hours or less of academic credit, a minimum of
 - a. 3.0 (C) average, except that a resident of Illinois whose scholastic average is below 3.0 but above 2.5 may, with the approval of the dean of the college concerned, be admitted on probationary status.
 - b. A nonresident of Illinois whose scholastic average is less than 3.0 will not be admitted.

Special Admissions. A student who is not eligible on one of the plans described above may be admitted, with the approval of the Dean of Admissions and Records and the dean of the college he wishes to enter, providing he submits evidence which clearly establishes his qualifications to do satisfactory work in the curriculum in which he wishes to enroll.

REVISION OF REQUIREMENTS FOR ADMISSION TO THE COLLEGE OF ENGINEERING

(8) The Urbana-Champaign Senate recommends that the specific requirements for admission of freshmen to the College of Engineering be revised to read as follows, effective for students enrolling in September, 1963, and thereafter:

In addition, applicants must meet the general requirements for admission to the University which are applicable to all students regardless of the college in which they enroll.

The increased subject matter requirements emphasize general education rather than specific preparation for engineering studies. Thus, biology as well as chemistry or physics may be presented to fulfill the science requirement. Social studies and foreign language requirements are added. The recent trend in engineering curricula to increase requirements in social sciences and humanities is reflected in an entrance requirement which will stimulate the prospective engineer also to include subjects in these areas and in language in his high school program.

Students who have only one unit of algebra and one unit of plane geometry may be admitted on condition that the deficiency is removed in the first year. No credit toward graduation will be allowed for mathematics courses taken to remove a deficiency in entrance requirements.

Required science must include two units from physics, chemistry, and biology. Botany and zoology may be substituted for biology. General science may not be used as a required subject.

Required language must be two units in one language. Languages which are acceptable are those normally taught at the University of Illinois and listed in the Undergraduate Study bulletin.

Students who are deficient in foreign language may be admitted on condition that the deficiency be removed in the first two years. No credit toward graduation will be allowed for language courses taken to remove a deficiency in entrance requirements.

Students transferring from other colleges shall not be excused from these entrance requirements unless they have demonstrated proficiency in the areas in which they are deficient.

On motion of Mr. Swain, this recommendation was approved.

CURRICULUM IN GENERAL ENGINEERING

(9) The Urbana-Champaign Senate recommends a new curriculum in general engineering leading to the degree of Bachelor of Science effective for students entering in September, 1960. The major change is to require a total of 142 semester hours for a degree exclusive of the required military training and physical education. The main reason for this change is that the Engineering Council for Professional Development accreditation criteria limits the amount of time permissible for secondary fields of study to six hours in a four-year curriculum. The faculty of the College of Engineering is of the opinion that anything less than twelve hours in secondary field study would detract from the effectiveness of the program and to obtain the additional six hours requires an increase from 136 to 142 hours. It is unlikely that this additional six hours will be a handicap to students, since a large percentage of those in the College of Engineering already take more than eight semesters to complete degree requirements.

The Senate Coordinating Council indicates that no other Senate jurisdiction is involved.

I concur.

On motion of Mr. Johnston, this recommendation was approved. Mr. Herrick voted "no."

REVISION OF CURRICULUM IN MINING AND METALLURGICAL ENGINEERING

(10) The Urbana-Champaign Senate recommends a revision in the curriculum in mining and metallurgical engineering by adding a three-hour course in statistics (Mathematics 263) and changing a course in mining engineering (Mining Engineering 253) from four semester hours to three semester hours.

The Senate Coordinating Council indicates that no other Senate jurisdiction is involved.

I concur.

On motion of Mrs. Watkins, this recommendation was approved.

REVISION OF CURRICULA IN MECHANICAL ENGINEERING AND INDUSTRIAL ENGINEERING

(II) The Urbana-Champaign Senate recommends a revision of the curricula in mechanical engineering and industrial engineering by dropping the course Advanced Drafting for Mechanical Engineers (General Engineering 112) from the second semester of the second year, changing the social sciences or humanities electives from a total of ten semester hours to nine semester hours, and adding a three-hour course in engineering analysis and design in the fourth year.

The Senate Coordinating Council indicates that no other Senate jurisdiction is involved.

I concur.

On motion of Mr. Swain, this recommendation was approved.

CURRICULUM IN CRAFTS

(12) The Urbana-Champaign Senate recommends authorization of a new curriculum in crafts in the College of Fine and Applied Arts, the objective being to provide a strong basis of fine arts, a foundation of general education centered in the humanities and social sciences, and a solid technical program in two of the three most important crafts areas.

Submitted herewith are the details of this new curriculum, a copy of which is being filed with the Secretary of the Board for record. The Senate Coordinating Council indicates that no other Senate jurisdiction

is involved.

I concur.

On motion of Mr. Swain, this recommendation was approved.

SHORT-TERM LOANS

(13) Fifteen years ago the University of Illinois held slightly over \$500,000 in loan funds, of which less than \$100,000 was loaned to students and the balance was invested in government securities. During the intervening period, the total of such funds has increased to \$744,000 all of which is now loaned or committed. At the present time there are insufficient funds to meet approved applications, and loans are being made solely from repayments on outstanding notes.

The University makes two types of loans: long-term loans, which are repaid in installments beginning four months after the student leaves school; and short-term loans, which are generally in amounts of less than \$100, bear no interest, and are payable within the semester in which they are made. The sum of \$39,000 has been assigned from certain loan funds, the terms of which are sufficiently liberal to permit them to be used for short-term purposes.

During the past semester the demand for short-term loans has continually exceeded available resources, and it has been necessary to temporarily assign cash from long-term funds for which the demand is also greater than the available resources. Without some assistance it will be necessary to refuse many applicants for short-term loans after the beginning of the second semester.

The University of Illinois Foundation holds a substantial cash balance in the Shaw Endowment Income account which may be used for educational purposes and is generally used for scholarships. These funds will not be needed until the first semester of 1960-61, and the Board of Directors of the Foundation has agreed to make a temporary grant of \$20,000 from them to the University for shortterm student loans during the second semester of 1959-60, to be repaid by September I, 1960. Although this is not a solution to the student loan problem, it will provide temporary relief.

The Vice-President and Comptroller and the Dean of Students recommend acceptance of this grant under the condition stated.

On motion of Mr. Hughes, this recommendation was approved.

SALE OF SECURITIES RECEIVED FROM LAKELAND FOUNDATION

(14) Mr. F. B. Hubachek of the Lakeland Foundation has made a gift to the University of Illinois of one hundred and forty-seven shares of the common stock of the Household Finance Corporation with a request that the stock be sold and the proceeds credited to the Lakeland Foundation gift account to which Mr. Hubachek has made cash donations each year for a number of years. The Lakeland Foundation gift to the University was established several years ago to carry on a research program in the Department of Clinical Science of the College of Medicine.

Since the stock was given to the University by the Lakeland Foundation with the stipulation that it be sold, the following resolution should be adopted to authorize the sale of the stock. The stock had a value of \$26.75 a share at the time of the gift on December 22, 1959.

Resolution

WHEREAS, the Board of Trustees of the University of Illinois is the owner of one hundred and forty-seven shares of the common stock of the Household Finance Corporation, and

WHEREAS, it is the decision of said Board of Trustees to sell and dispose of this stock.

Now, Therefore, Be It Resolved that this sale be completed and that A. J. Janata, Secretary, and H. O. Farber, Comptroller, be authorized to execute all documents necessary to accomplish this.

ELECTRICAL SERVICE FOR LAUNDRY BUILDING CHICAGO PROFESSIONAL COLLEGES

(15) The Director of the Physical Plant and the Vice-President and Comptroller recommend authorization of an agreement with the Commonwealth Edison Com-

pany, Chicago, for the installations necessary to supply electrical service to the new Laundry Building at the Chicago Professional Colleges at a cost of \$3,153. The work will include construction of a duct run from the Edison Company's manhole in the street to the property line, installation of cables from the manhole to the Laundry Building, setting of transformers, and cable work within the transformer vault.

Funds are available in the construction budget for the Laundry Building. I concur.

On motion of Mr. Harewood, this agreement was authorized by the following vote: Aye, Mr. Clement, Mr. Harewood, Mr. Herrick, Mr. Hughes, Mr. Johnston, Mr. Pogue, Mr. Swain, Mrs. Watkins, Mr. Wilkins, Mr. Williamson: no, none: absent, Mr. Stratton.

ENGINEERING SERVICES FOR EXTENSION OF UTILITIES TO ASSEMBLY HALL

(16) Provision was made in the state capital appropriations for 1959-61 for all utilities services to the Assembly Hall, including steam, electric, water, and storm and sanitary sewers. The funds are subject to release by the Governor and as a result of the "freeze order" on capital funds, all engineering work on utilities services was stopped. As it now appears that the University will not secure a release of funds in time to complete utilities by the time the building is con-structed, an alternate method must be found to provide and finance temporary utility services. Preliminary studies of alternate methods of providing utilities services indicate that:

A temporary storm sewer, estimated to cost approximately \$30,000, is the most critical and immediate need of the contractor. It is only a partial solution, and there may be periodic flooding and closing of the new Florida-Kirby underpass during periods of heavy rainfall.

An additional capital expenditure of approximately \$165,000 will be necessary to finance the cost of construction of a temporary oil-fired heating plant and the extension of Illinois Power Company electric service to the site. These temporary services will, however, result in a net increased operating cost of approximately \$84,000.

There is no temporary solution for water and sanitary sewer service, and the permanent facilities originally contemplated and estimated to cost approximately \$38,000 will be required.

The Assembly Hall is being financed through a bond issue, and funds can be made available in the building construction account for the cost of the engineering services and the electric lines. The biennial operating budget includes funds for operating the Assembly Hall during 1960-61, but since the building will not be occupied before the fall of 1961, these funds can be used to finance the con-struction of the water mains, sewer, and heating plant. The Director of the Physical Plant and the Vice-President and Comptroller

recommend that:

Sargent and Lundy, Consulting Engineers, Chicago, be employed on the engineering services required for the construction of a temporary oil-fired heating plant. The estimated cost of these services is \$10,000.

Wilson and Anderson, Champaign, be employed to do the engineering work required for the water and sanitary sewer services. The estimated cost of these engineering services is approximately \$3,800.

It is recommended that authorization of these two firms be by changes in the existing contracts with them previously authorized by the Board.

The Vice-President and Comptroller and the Secretary of the Board be authorized to execute a contract with the Illinois Power Company for extension of electrical service to the site at an estimated net cost of approximately \$15,000.

Recommendations will be submitted for awards of contracts and assignments of funds for the construction of the temporary heating plant and the extension of storm and water sewer services when these services have been designed and bids have been taken.

The Committee on Buildings and Grounds has previously considered these recommendations and is prepared to support them.

ENGINEERING SERVICES ON EXTENSION OF UTILITIES TO HOUSING AREAS

(17) The Director of the Physical Plant and the Vice-President and Comptroller recommend additions to an existing contract with Wilson and Anderson, Champaign, for engineering services, authorized by the Board on February 19, 1959. to include design for (a) extension of the Mathews Avenue sanitary sewer interceptor from Illinois Street to Florida Avenue; (b) a water main, lift station and force main, and a sanitary sewer to service the additional family housing to be constructed in the area between South Race Street and Orchard Avenue extended. The extension of the Mathews Avenue sanitary sewer interceptor will also serve the residence halls for women to be constructed south of Florida Avenue and west of Lincoln Avenue and eventually other buildings.

The estimated cost of these engineering services is \$14,000 and will be paid from the proceeds of the bond issue to finance the construction of the family housing units already authorized by the Board. If funds in the state capital

appropriations to the University for 1959-61 are released, it is proposed to charge \$9,500 of the cost of these engineering services to the appropriation for extension of utilities.

I concur.

On motion of Mr. Johnston, these contract changes were authorized.

AMENDMENT OF GENERAL RULES CONCERNING UNIVERSITY ORGANIZATION AND PROCEDURE

(21) The Committee on Fees recommends that Section 30, Registration of Staff Members in University Classes, in the General Rules Concerning University Organization and Procedure be amended effective September 1, 1960, as shown below. The new language is shown in italics.

A subtitle of the Section is added to read: Registration of Staff Members in Undergraduate Colleges.

The present paragraph (a) to be changed to read:

Undergraduate students on the academic, administrative, or permanent nonacademic staff of the University, or on the staffs of allied surveys and laboratories located on the Urbana-Champaign campus, may register in University courses for which they are eligible for admission, without payment of the tuition fee and the laboratory, library, and supply fee, provided that their annual salary for nine months is less than the minimum salary for such period established for full-time assistants, and provided that their official appoint-ments call for a minimum of four months of service during the semester in which exemption is desired. (A semester is defined for this purpose as the equivalent of four and one-half months of work.)

(The latter change is regularizing precisely what is being done at the present time.)

Paragraphs (b) and (c) are not changed.

The present paragraph (d) to be deleted.

The present paragraph (e) to be changed to read:

(d) Undergraduate students on appointment for a second semester who are exempt from payment of fees for courses in which they are registered during the period of their appointment are exempt also from a payment of fees for courses in which they enroll in the Summer Session immediately following termination of their appointments, provided they hold no appointments in that Summer Session. Undergraduate students holding summer session appointments requiring at least seven weeks of service shall be subject to such tuition and fees as would be assessed in accordance with the principles expressed in (a) and (b) above.

(Undergraduate academic and nonacademic employees have had the same privileges as graduate employees insofar as they concern extension of the tuition and fee exemption benefits to the Summer Session immediately fol-lowing termination of their appointments. The recommended revision of former paragraph (e) now paragraph (d), as indicated, provides for the undergraduate employees the same summer session exemptions proposed for the graduate academic staff.)

A new paragraph (e) to be added:

(e) Undergraduate students not subject to tuition and fees by reason of their appointments who resign from their positions before the midpoint of the

.

semester or Summer Session and continue as students after the date of resignation shall be subject to payment of tuition and fees. A new subsection, with a subtitle, to be added:

Registration of Staff Members in the Graduate College

(f) Graduate students who are academic employees of the University, or of allied surveys and laboratories located on the Urbana-Champaign campus, may register in University courses for which they are eligible for admission without payment of the tuition fee and the laboratory, library, and supply fee, provided their official appointments call for not more than 62.5 per cent of full-time services for a minimum of four months during the semester in which exemption is desired. Graduate students employed under two or more appointments from the University or allied surveys and laboratories shall have their basis for exemption computed on an equivalent scale. Graduate students not subject to tuition and fees by reason of their appointments who (1) resign from their positions before the midpoint of the semester, (2) complete clearance for graduation within one week following the date of resignation, and (3) leave the campus, shall not be subject to payment of tuition and fees for that semester and they need not cancel their registration in University courses for the semester. Such persons who continue as active students after the date of resignation shall be subject to payment of tuition and fees.

(g) Those graduate students, including fellows, who are not exempt from the payment of tuition and fees in accordance with paragraph (a) above shall be subject to payment of tuition and fees unless they are awarded tuition and fee waivers (in whole or in part) by the Graduate College. These tuition and fee waivers shall be awarded at the discretion of the Graduate College as authorized by the Board of Trustees.

(h) Graduate students holding appointments during the second semester of an academic year either as employees or fellows, and for whom tuition or fees have been provided through exemption, waiver, or cash payment by an outside agency, shall be exempt from the payment of the same kinds of tuition and fees for the Summer Session immediately following, provided they hold no appointments during the Summer Session. Graduate students holding summer session appointments as fellows or as employees requiring at least seven weeks of service shall be subject to such tuition and fees as would be assessed in accordance with the principles expressed in sections (a) and (b) above.

(i) These rules do not apply to graduate nonacademic employees who are governed by the same regulations applying to undergraduate employees, as stated in paragraphs (a) through (e) above.

(j) Graduate students who hold any type of University appointment including that of fellow, may not accept additional employment from the University or any allied agency without the approval of the Dean of the Graduate College. I concur.

On motion of Mr. Swain, these amendments were adopted.

TUITION AND FEE WAIVERS IN THE GRADUATE COLLEGE

(22) The Dean of the Graduate College recommends authorization of 450 tuition and fee waivers a year to graduate students which would include (a) all University fellows, i.e. those whose stipends are paid from University funds; (b) most fellows whose stipends are paid from endowments or other trust funds received by the University for such purposes; (c) a number of teaching assistants who for reasons beyond their control may be compelled to accept teaching assignments which do not carry exemption from payment of tuition and other fees on the basis of their appointments; and (d) all foreign graduate students who qualify for tuition and fee waivers. This latter would leave present foreign scholarships available exclusively to undergraduate students.

available exclusively to undergraduate students. It should be noted that the term "tuition and fee waiver" is used here rather than the term "scholarship." This is a desirable change in nomenclature which would leave the term "scholarship" to apply to undergraduate students only.

I concur in this recommendation.

On motion of Mr. Herrick, this recommendation was approved.

ADMISSION OF UNDERGRADUATE STUDENTS ENTERING DIRECTLY FROM HIGH SCHOOL

(23) The present requirements for admission of undergraduate students entering directly from high school include a provision that a graduate of an accredited high school who is a resident of Illinois and whose scholarship is in the lowest quarter of his class, but who otherwise meets the entrance requirements, will be admitted on probationary status subject to certain conditions, including: "Such an applicant will be required by the University to take tests as prescribed by the Student Counseling Service and to receive in an interview an interpretation of the test scores and their educational and vocational significance."

The Director of Student Counseling Service and the Dean of Admissions and Records recommend that the language of the phrase in italics be amended to read: "... and to receive a letter advising him of his chances of succeeding in the University and inviting him to utilize the services of the Student Counseling Service for interpretation of the educational and vocational significance of his test scores if he so wishes."

Since this is an administrative procedure and involves no change in policy, I have approved the change, effective at the beginning of the first semester of 1960-61, and report this action for record.

DISCLAIMER REQUIREMENT IN STUDENT LOAN FUND PROGRAM OF NATIONAL DEFENSE EDUCATION ACT

(24) The University of Illinois Board of Trustees registers its objections to the disclaimer or affidavit of disbelief oath required of student recipients of federal loans under the National Defense Education Act and urges that the Congress remove the disclaimer oath provisions from the Act during its present session.

The Board, at the same time, emphasizes its approval of the allegiance oath requirement for such loans.

The Board states that despite its objection, the University will continue to participate in the federal loan program if the disclaimer oath is not removed. To withdraw would force many of the more than 400 students now holding federal loans to leave the University since loan funds from other sources are exhausted.

Under these circumstances it seems best to leave to the individual student the decision as to whether or not the taking of the disclaimer oath can be reconciled with the dictates of his conscience.

The foregoing statement was presented by the Vicc-President and Provost, representing the President of the University, with the recommendation that it be adopted as the official position of the University on this question.

During the discussion of the recommendation, Mr. Hughes suggested that in lieu of registering objection to the disclaimer oath, the Board recommend a change in the language to remove the objectionable features.

Mr. Harewood stated that in his opinion the Board should not undertake to redraft any provisions of the National Defense Education Act but that it should express its position in general terms.

Mr. Clement spoke in opposition to the disclaimer oath.

At the conclusion of this discussion, on motion of Mr. Clement, this statement was adopted by the Board. Mr. Herrick and Mr. Hughes voted "no."

LIBRARY OF INTERNATIONAL RELATIONS

(25) On November 18, 1959, the Committee on General Policy received a report from the Dean of Library Administration on the availability to the University of the Library of International Relations at 351 East Ohio Street, Chicago. The future of this Library has been a subject for urgent consideration because of its financial problem, and a firm offer was received from Michigan State University for its removal to East Lansing. Desiring to keep the Library in Chicago, its Trustees have suggested a possible affiliation with the University of Illinois. The Committee on General Policy voted to support the University administration's interest in acquiring the Library of International Relations and the Dean of Library Administration was authorized to negotiate with its Trustees.

The Library's distinguished collection consists of more than 150,000 books, pamphlets, periodicals, and other materials and is valued by its Trustees at a minimum of \$500,000. It was developed largely through the financial backing of Chicagoans, and its usefulness increases with Chicago's expansion as a seaport. These are among the many strong practical reasons for keeping the Library in Chicago permanently.

The Trustees of the Library of International Relations have requested an official expression from the Board of Trustees of the University of Illinois of the University's interest in acquiring the Library, this expression to cover specifically two points:

- "1 That every reasonable effort is to be made to provide a permanent location for the L.I.R. which will be convenient for the Library's established clientele;
- 2. And that the L.I.R. is to be recognized permanently as a distinctive professional collection, with the intent of maintaining it as such rather than merely as a department of an undergraduate library."

The Dean of Library Administration recommends that the Board of Trustees of the University of Illinois officially express to the Trustees of the Library of International Relations the willingness of the University of Illinois to acquire their Library under the following conditions:

- I. It will be housed, as a separate unit, in the new library building of the Chicago Undergraduate Division when such a building is erected, and will be maintained as a specialized collection available to the clientele it now serves, as well as to the faculty and students of the University.
- 2. Special programs of the Library of International Relations, such as discussion groups, seminars, and other types of public relations programs now sponsored by it, will be continued.
- 3. Since any library that stops growing soon becomes dead or obsolete, the L.I.R. resources will be developed continuously in the fields covered by its present program. This implies systematic acquisition of materials by purchase, exchange, and gift, and the availability of regular operating funds.
- change, and gift, and the availability of regular operating funds.
 4. Since it is important that the present Board of Trustees of the Library of International Relations and Governing Members continue their association with it, following affiliation with the University, these groups would be organized into a "Friends of the Library Society," such as is found in a number of institutions. Except for administrative responsibility, the Society would carry on most of the activities with which the present Trustees and Governing Members are now concerned. Administratively, the Library of International Relations would be attached to the University's Chicago Undergraduate Division Library which reports to the Dean of Library Administration of the University of Illinois.
- 5. The transfer of the Library of International Relations would include transfer of its staff to the library staff of the University of Illinois.
- 6. The University will include in its biennial budget estimates for 1961-63 provision for partial financial support of the Library.

If the Board of Trustees approves the foregoing recommendations, it is further recommended that the University's administrative officers be authorized to pursue negotiations with the Trustees of the Library of International Relations with a view to arriving at a firm agreement with regard to the transfer of the Library to the University when the library building on the new Chicago Undergraduate Division campus is completed.

On motion of Mr. Johnston, these recommendations were approved.

EXECUTIVE SESSION

SALE OF LAND TO ALPHA GAMMA RHO AND DELTA CHI FRATERNITIES

(26) The Committee on Buildings and Grounds has approved the sale of two tracts of University land adjoining the properties of the Alpha Gamma Rho and the Delta Chi fraternities in the block bounded by Armory Avenue on the north, First Street on the east, Gregory Drive on the south, and Oak Street on the west in the city of Champaign to permit remodeling and expansion of their houses.
